The Utility District will set a tap and meter at the road right-of-way or property line. If the water main is not adjoining the property in which service is being requested, approval from the district must be acquired for extending the water main. All new service connections must be approved by the Utility Manager.

New service connections will be installed within 60 days, weather and permits permitting.

I agree to use the water in accordance with the rules and regulations of the District and to promptly pay for the water at the applicable schedule of rates and time schedule as set forth on statements.

It is understood and agreed that a tapping fee of \$2000.00 for a ¾" water connection will be charged and a \$100.00 Non-Refundable Service Connection Fee to be made by applicants subscribing for water service prior to having service rendered. **(Total Tap Fee= \$2100.00)**

**All active taps and meters installed at the above address are subject to a minimum monthly billing charge currently set at \$19.79 per month. The amount becomes active once the tap has been set.**

**Bills are due on the 20<sup>th</sup> of each month. If the water bill is not paid by the Fifth of the following month the water service will be disconnected.**

The undersigned agree/s that he/she is responsible for charges incurred on the account and if the account has to be placed with a collection agency or attorney that he/she will pay any and all reasonable costs of collection and/or attorney fees.

I agree and understand the rules and regulations of the District, that there can only be ONE (1) residence serviced per meter.

\_\_\_\_\_ Property Renter: Agrees to pay \$150.00 **Non-Refundable Service Connection Fee**

**\*\*Both Property Owner & Property Renter understand that the service connection fee will not be refunded. \*\***

The District will endeavor to furnish continuous water service but does not guarantee to the customer any fixed pressure or continuous service. Therefore, the District suggest the homeowner furnish a pressure reducer in order to regulate high water pressure. The District shall not be liable for any damages or interruption of service whatsoever. In connection with the operation, maintenance, repair, and extension of the city water system, the water supply may be shut off without notice when necessary or desirable and each customer must be prepared for such emergencies. The District shall not be liable for any damages from such interruption of services or for damages from resumption of service without notice after any such interruption.

**There will be a \$40.00 reconnection fee during normal business hours and \$75.00 after normal business hours of 8:00am to 4:00pm Monday thru Friday.**
